## MESSAGE FROM THE CHAIRPERSON



*The year became memorable and difficult for the human civilization because of the global effects of COVID-19. The pandemic brought various threats to human rights protection, promotion and fulfilment.*

INSEC is pleased to share its Annual Report 2020 that includes the INSEC's activities movements and engagement throughout the year 2020. This report contains major achievements and interventions carried out programs under INSEC Strategic Plan 2019-2023. Human Rights Documentation, Human Rights Awareness, Human Rights Advocacy as well as Institutional development are the key programs of INSEC. There are various projects and strategies interventions that supported to accomplish the target stipulated in the strategic plan. Social mobilization, empowerment of the rights holders to enhance the accountability of responsive agencies, lobby/advocacy campaign, network mobilization and partnership with the civil society organizations, monitoring of human rights violation cases at the primary level, publication of reports in a print and digitized forms, thematic studies, engagement with government and international institutions are some of the key highlights in this reporting period.

I believe that the engagement of our team in human rights protection and promotion has contributed providing justice to the victims. INSEC, as a frontline civil society organization, is dedicated for the protection and promotion of human rights for social justice in Nepal. This reporting period has wide experiences with the different challenges and opportunities. As the federal system itself has provided ample of opportunities for the country. Lack of skills, resources to manage the system has created hurdles to provide services to the ordinary people. The ruling party CPN which is serving as the majority government faced internal contradiction that creates obstacle for the effective parliamentary exercise. The status quo of impunity remained one of long pending issue as a challenge to the civil society organization. The government's commitment to amend the Transitional Justice related laws and policies were still pending. The Transitional Justice commission and commission on disappeared person failed to deliver any progress in delivering justice to the victims.

The year became memorable and difficult for the human civilization because of the global effects of COVID-19. The pandemic brought various threats to human rights protection, promotion and fulfillment. The rights to health became major concern of the people around the globe. INSEC also faced different challenges in its program implementation. Most of the activities were confined through virtual medium.

This year INSEC has published its 28<sup>th</sup> edition of Nepal Human Rights Year Book which has documented the incidents of human rights violation and abuse across the country of 2020. The Year Book has reflected the cases of rape, attempt to rape, sexual violence, harmful social practices like witchcrafts, dowry practices and Chaupadi are the major contributing factors to increase women rights violation in Nepal. We have pointed out to focus more on to make a gender friendly policies and protection mechanisms for the women from the marginalized section of the society.

During the reporting period, INSEC has focused its program on enabling the people, especially women and children from the marginalized communities to assert their rights to education, food, health and housing. In our learning the groups have been capacitated through various activities to make claims regarding various economic, social and cultural rights with the concerned government stakeholders. INSEC has kept its efforts through its programs in exerting pressure for the ratification of international human rights treaties, documentation and monitoring for the effective implementation of the ratified treaties. INSEC has also facilitated to strengthen a coordinative and collaborative relation between the local and provincial government mechanisms, supported to formulate human rights friendly laws and policies at the local level, contributed in capacity enhancement of local judicial committees etc.

Finally, I would like to express my sincere gratitude to our partners and donors for trusting us to achieve our goal. The collective efforts, partnership and collaborative interventions with all our well-wishers are equally important in this journey. I sincerely thank to INSEC Executive committee members, staffs and volunteers for their continued commitment to achieve our goals towards protection and promotion of human rights. I wish all the best.

## ABOUT INSEC

Informal Sector Service Centre (INSEC), a non-governmental organization established in 1989, works to protect and promote human rights for social justice in Nepal. Its programs are dedicated to protecting human rights through monitoring and documenting of human rights situations; strengthening the capacity of local people and institutions to claim their rights, and advocacy for a human rights friendly environment.

INSEC started its work for the economic rights of the cart pushers of the Kathmandu valley at the beginning. In course of time, it has gradually identified its core proficiency areas and issues of human rights to intervene. It organizes campaigns, awareness and education programs for making people capable for asserting their rights. Furthermore, it conducts monitoring and documentation of human rights situation of the country, disseminate the information materials at local, national, and international arenas.

INSEC believes itself as a campaigner to promote “human rights for all.” Hence, it has worked continuously for the enactment of human rights friendly laws, policies and plans aiming at further strengthening human rights culture in the country. Specifically, monitoring, documentation, and reporting of human rights situation in Nepal has been the major work. INSEC has been publishing Nepal Human Rights Year Book since 1992 as its regular work. In addition, it is also coordinating with the civil society networks at the national, regional, and international level.

INSEC works in all 77 districts through its district representatives. It has seven provincial offices and a central office in Kathmandu. INSEC is the Secretariat of Human Rights Treaty Monitoring Coordination Centre (HRTMCC), a network of more than 78 human rights NGOs at national level. INSEC also works as the Secretariat of Nepal NGO Coalition for the Universal Periodic Review (NNC-UPR) – a coalition of 440 active human rights organizations.

Informal Sector Service Centre (INSEC) believes that social justice is the ultimate impact it dreamt of and contribute to achieve from our programs and interventions. INSEC considers that the valid process and fundamental issues are equally important on ensuring social justice. 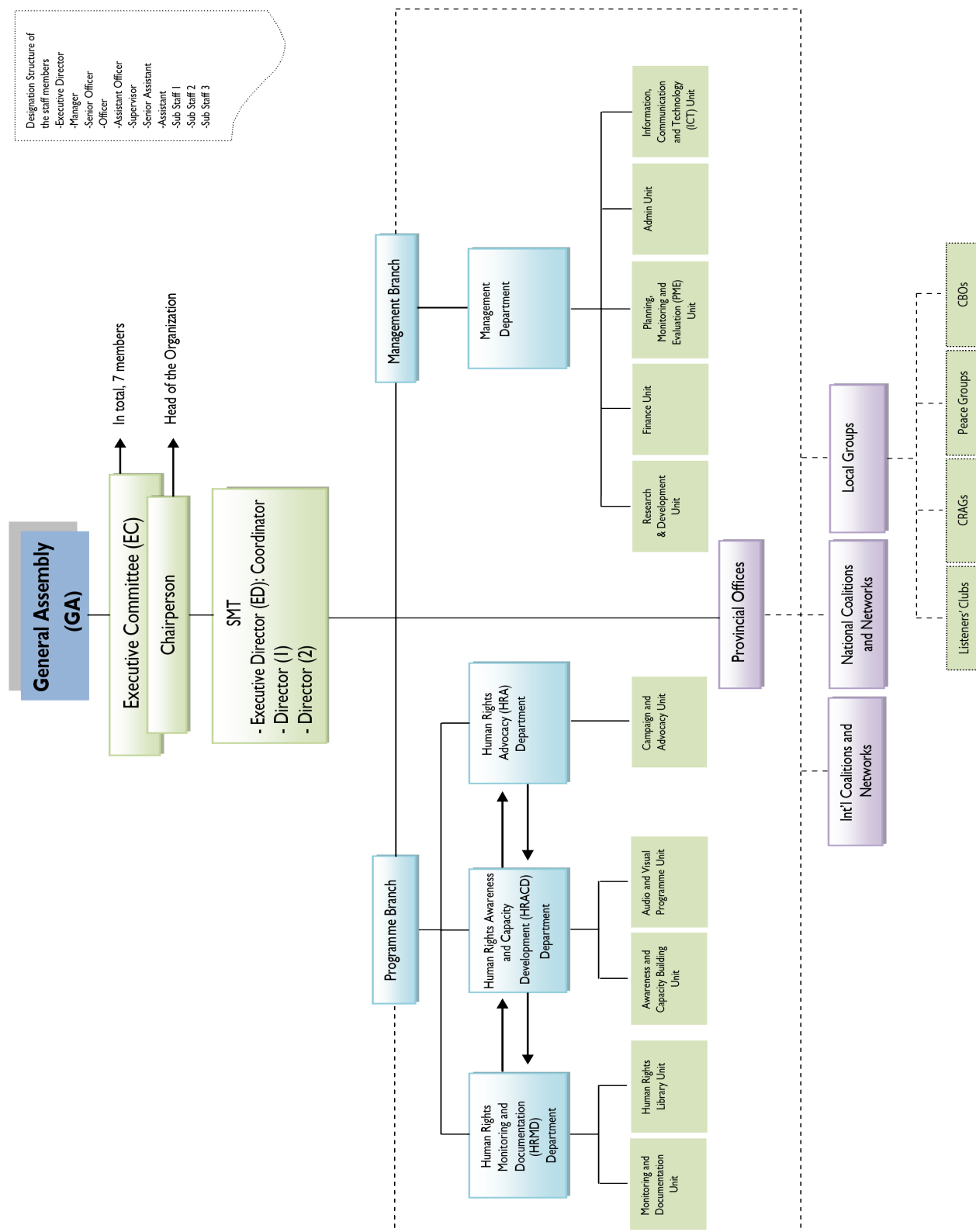

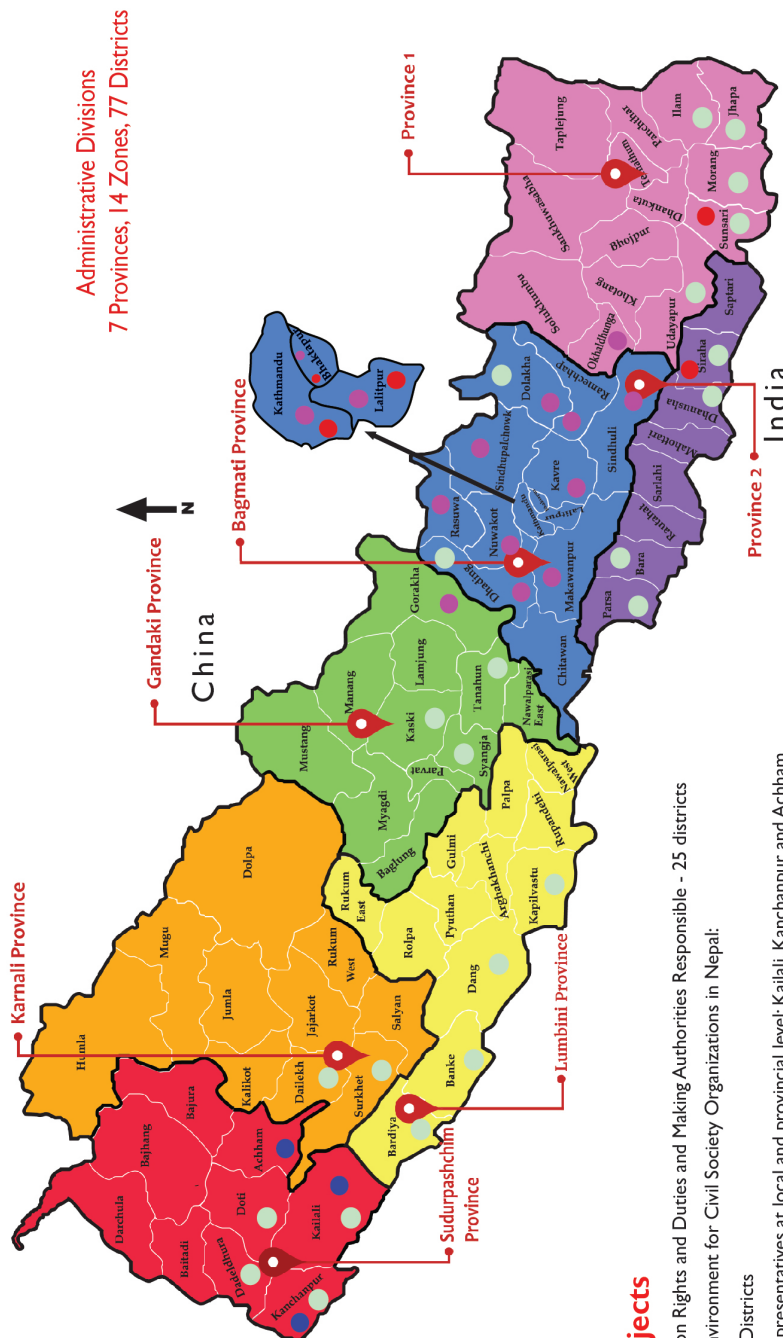

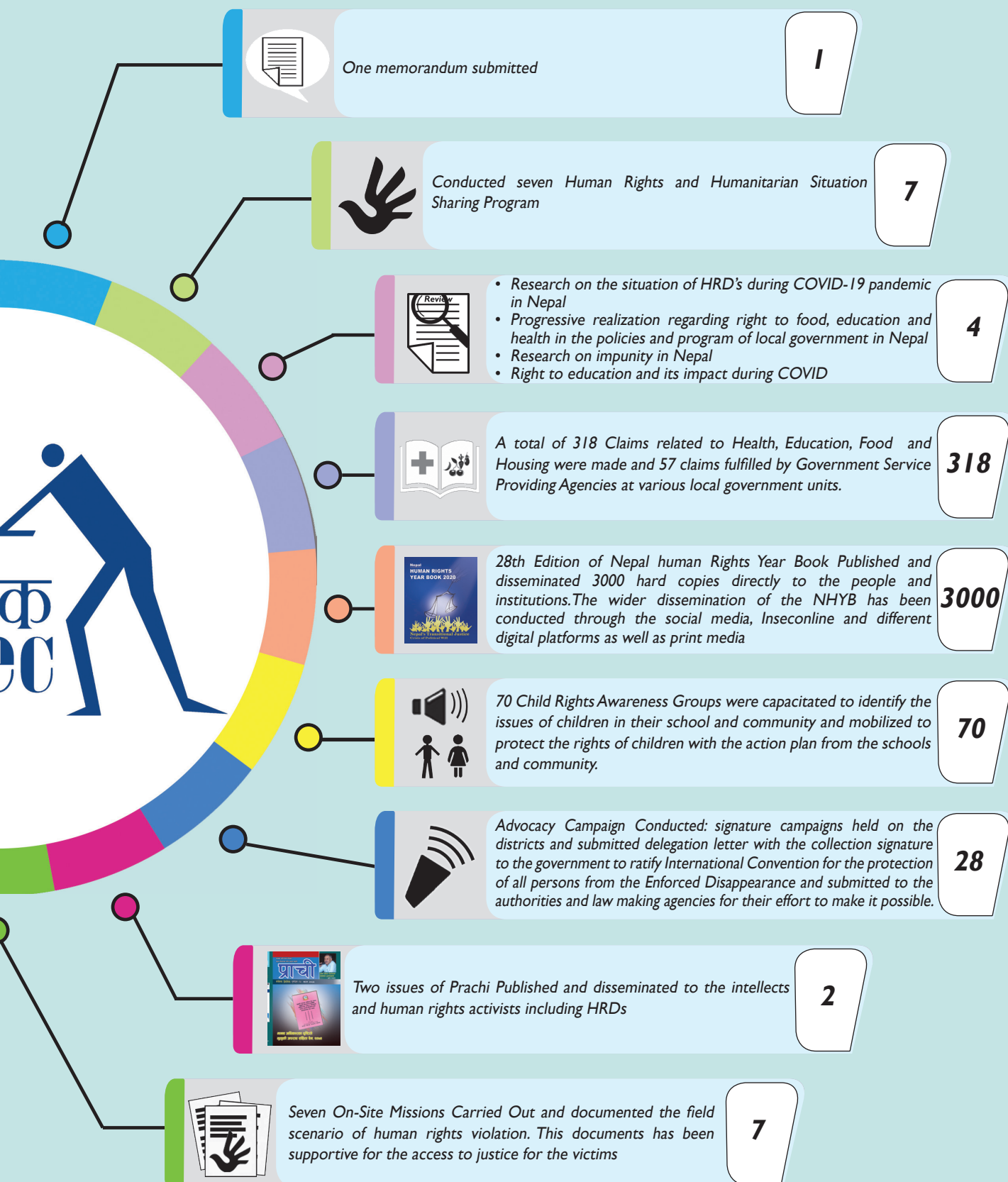

This program aims to contribute to the protection and promotion of human rights through monitoring and documentation of human rights violations or abuse across the country. INSEC disseminates the human rights news and information through [www.inseconline.org](http://www.inseconline.org) since 2004.

Nepal Human Rights Year Book has been publishing by INSEC since 1992 as a principle document to reflect the overall situation of human rights of the year. The long-term objective of this program is to reduce human rights violations to enhance justice. INSEC provides emergency support to the needy victims along with Human Rights Defenders. In addition, press release and fact-finding missions are carried out to support the achievement of the project.

# PROJECT CONTRIBUTION

## STRENGTHENING ENABLING ENVIRONMENT FOR CIVIL SOCIETY ORGANIZATIONS IN NEPAL



» Workshop on the Civil and Political Rights as well as Economic, Social and Cultural Rights at Dhangadhi

The project “Strengthening Enabling Environment for Civil Society Organization in Nepal” is being implemented by INSEC in partnership with Civil Society: Mutual Accountability Project (CS: MAP) of FHI 360 to contribute in its objective I: Strengthened enabling environment for civil society and media. The project was designed during the period of constitution drafting process and the program implementation begun only after the promulgation of the Constitution of Nepal. The objectives of the program is mention below:

- Improved legal and policy framework, based on international standards to create an enabling environment for civil society
- Improved public understanding and confidence in the role of civil society organizations
- Improved self-regulation of the sector and internal governance of CSOs

These objectives were expected to be achieved through three types of strategic interventions as the key activities incorporating Gender Equality and Social Inclusion (GESI) across all project areas and activities i.e. (a) lobby/ advocacy through meetings, interactive dialogue, delegations to concerned stakeholders for enacting SWD Act, (b) awareness raising through public hearings and interactive discussions

between public and CSOs and building synergy among CSOs for making public understanding and retaining public trust, and (c) interactive discussions and capacity development of CSOs to promote good governance.

### Key Achievements

- During this project period, INSEC had conducted interaction programs among CSO activists and stakeholders to get the current scenario of CSO related law making and engagement of CSO activists, equally coordination with NGO Federation of Nepal and other stakeholders. It brought together different stakeholders to enhance the engagement of activist during the preparation of national human rights action plan for ensuring the guarantee of state's constitutional and international obligations.
- During this reporting period, INSEC engaged with the different Ministries, Parliamentary Committees, Nepal Law Commission, Office of the Prime Minister and Council of Ministers (OPMCM), other stakeholders and civil society networks to review various laws and make necessary changes.
- INSEC conducted the review of the proposed Human Rights Commission Act Amendment Bill and conducted the advocacy meeting among the representative from CSOs, National Human Rights commission and Parliamentary Committee for Law, Justice and Human Rights. The amendment bill was repelled by the Government.
- Ministry of Home Affairs (MOHA)'s on draft bill which intended to control the civic space and rights to freedom of association repelled because of the proactive initiation of the Ministry for Women, Children and Senior Citizen. INSEC together with the civil society organizations advocated for changing MOHA's proposal.
- INSEC through series of interactions, discussed on the issue of CSOs' problem in getting renewal of the tax exemption certificate from the Inland Revenue Office. INSEC from its field experience collected the evidence from few CSOs to renew such certificate and conducted meeting with the IRD.

## HUMAN RIGHTS PROMOTION AND PROTECTION INITIATIVES

The project “Human Rights Promotion and Protection Initiatives” is implemented by INSEC in the support of FHI 360 with the objective to improve enforcement of fundamental human rights enshrined in the Constitution. The goal of CS:MAP-HRS is to improve the capacity of local government and federal government to promote and protect the rights of marginalized people. INSEC has facilitated and contributed to achieve targeted results under the following objectives:

- To promote the Government's compliance with the United Nations' Universal Periodic Review (UPR) and Human Rights Treaties, especially its reporting obligations;
- To engage and advocate with the Government to draft a new National Human Rights Action Plan (NHRAP) and its effective implementation, in collaboration with CSOs
- To strengthen partnership with local

Government to promote, protect, respond and facilitate the rights of marginalized people

### Key Achievements

- INSEC as the Secretariat for the non-governmental organization (NGO) Coalition for the United Nations' Universal Periodic Review (UPR) and the Human Rights Treaty Monitoring Coordination Centre (HRTMCC) organized series of National Level Consultations for the CSO's UPR with civil society organizations and Government Stakeholders. During this consultation, issues received from the provincial consultations and issue-based interactions were shared during the meeting.
- INSEC reviewed three major policies including Local Health Service Act 2076, Market Management, Monitoring and Consumer Interest Protection Act 2076,

and Municipality Disaster Risk Reduction and Management Act 2076 of Birendranagar Municipality

- INSEC provided technical assistance to Birendranagar Municipality to develop and adopt human rights guidelines and standards. While preparing the HR guideline of municipality need and capacity assessment report was also considered

- INSEC provided capacity development trainings to LGBTIQ+, Dalit and marginalized communities to make aware about their rights, role and responsibility of the local Government to protect their rights. Evaluated the community of people/marginalized community's participation in the planning process in the last year and identified the existing gaps and interventions necessary to enable them to participate in this process.

## SAHAKARYA (COLLABORATION): YOUTH EXCHANGE PROGRAM

Sahakarya is a youth exchange program jointly implemented by INSEC and People's Vigilance Committee on Human Rights (PVCHR), based in India. Youths working in the field of human rights and community development from Nepal and India are selected for the program. During the selection; high priority is given to women and youths from the underprivileged community. During the exchange period participants spent a week in Norway, four months in Nepal and four months in India involving at the various social and community development activities. The main objective of this program was to support young people's participation in the capacity and leadership development in local, regional and international levels.

### Objectives

- Strengthen the capacity of youth volunteer on HR situations in terms of understanding, promoting and protecting the rights

- Strengthening the regional collaboration/network between the partners

### Key Achievement

- Youths have developed skills on human rights documentation as well as communication skills such as writing case studies and sending urgent actions. Youths have been identified the human rights issues and are using various laws and guidelines for doing intervention.
- Youths have been acting as local change agent for making change by imparting gained knowledge among adult women, adolescent girls and the minority children. Youths have been familiar with international contexts and cross-cultural issues, and are working directly with the community to reduce caste-based discriminations and other forms of violence.

## MOBILIZATION OF CAPACITATED HUMAN RIGHTS DEFENDERS FOR PROTECTION AND PROMOTION OF HUMAN RIGHTS IN NEPAL

The project has focused its interventions towards mobilization and capacity enhancement of Human Rights Defenders (HRDs). The intervention had its target to strengthening the networks, capacity and performance of HRDs for social justice and human rights friendly environment. The project contributed for the capacity enhancement of HRDs through exposure, social mobilization, training, advocacy, and networking.

- Improved situation of human rights defenders
- Digitization of Nepal Human Rights Year Book
- Support to formulate HRD Protection law in province assembly

# MAJOR EVENTS OF THE YEAR

## NEPAL HUMAN RIGHTS YEAR BOOK 2020 LAUNCHED

Nepal Human Rights Year Book 2020 published by Informal Sector Service Centre (INSEC) was launched in a program held at Lalitpur on February 19, 2020. The book was launched by Mr. Sushil Pyakurel, Founder Chairperson of INSEC, and Former Commissioner of National Human Rights Commission, Former Political and Human Rights Expert to the President of Nepal. This is the 28th edition of the book.

Since 1992, this book has been published compiling all the incidences of human rights violations and abuses. At the launch, the founder Chairperson of INSEC Sushil Pyakurel emphasized on Transitional Justice and government's role to be make Transitional Justice issues as a priority of the government. Government should focus to protect the citizen's Economic, Social and Cultural Rights. He pointed that government had brought the state and the conflict group together for reconciliation. However, the government had failed to give conclude and tangible result to the Transitional Justice process. He further added that the government should focus to stop the series of impunity culture.

Executive Director of INSEC Mr Bijay Raj Gautam shared the data of human rights violation and abuse of 2019 in which there were 6642 victims whereas in 2018 the number of victims was 5110. In 2019, the number of victims of human rights violations was 930 among which 68 were females and 862 were males. Similarly, there were 5712 victims of human rights abuses which include 5058 females and 654 males. In comparison to the data of 2018, there has been an increase of 1532 victims in the year 2019.

He further informed that this year there were seven deaths caused by police shootings – two in Bhojpur, one in Saptari, two in Sarlahi, one in Rupandehi and one in Kapilvastu. There were 13 victims of torture, 702 arrests, 62 victims of discrimination, 40 of inhumane behaviour, 98 victims were deprived of their right to assembly, 35 victims of threats and 279 victims of beating. Similarly, there were eight victims of displacement and two victims of enforced disappearances.

On July 21, 2020, INSEC Executive Committee decided to honour Dr Roop Chandra Bishwakarma, a well-known doctor for his dedication and hard work at Bajura hospital of Sudurpashchim province to be conferred, with Prakash Human Rights Award. He was rewarded for his initiative and contribution in the health sector for the deprived and marginalized citizens of Bajura District. He has been awarded with Rs 50,000 as the cash prize, with a certificate of appreciation and INSEC's emblem.

On July 31, 1992, INSEC's Founder Secretary General Mr. Prakash Kafle had lost his life in a crash of Thai Airways at Ghoptebehir in Nuwakot. To mark the contributions of Late Kafle in the journey of Nepal's human rights and social justice, the Prakash Memorial Award was formed and initiated. Individuals who have made outstanding contributions in the field of human rights, politics, education, health and social affairs of Nepal were rewarded on the occasion of Prakash Memorial Day. So far, there are twenty-five individuals are rewarded by this award.

## NATIONAL CONSULTATION ON UNIVERSAL PERIODIC REVIEW (UPR)

National consultation with members of three coalitions, National Coalition, Woman Coalition and Durwan Review Conference was organized on 27 February, 2020 in Kathmandu. The program was conducted with the objective of collecting suggestions from different thematic groups and organizations on the draft report of UPR. The program focused on mainstreaming the agendas for the review of documents and suggestions provided by the international stakeholders during UPR session. Coalition members and Civil Society organizations shared the major suggestions, recommendations and inputs in draft report during the program. Furthermore, area of government priorities in human rights and other activities were also prioritized and suggested in a effective way.

Major issues of Transitional Justice, violation against woman, right of minorities were also discussed, for the way forward. Suggestions from Dalit, Religious minorities, person with disabilities and other groups raised the real situation and area of improvement for the government and also for the CSO. During the discussion a common issues were agreed, accountability for the states responsibility to enhance the human rights, issues of discrimination, issue oof rule of law were noted.



## CONSULTATION ON THE ROLES AND RESPONSIBILITY OF PROVINCIAL GOVERNMENT FOR THE PROTECTION AND PROMOTION OF HUMAN RIGHTS DEFENDERS RIGHTS

Province level consultation meeting accomplished in Dhangadhi on 16<sup>th</sup> September 2020. Participation of 27 persons from member of parliament, representatives from human right defender networks, civil society organizations and journalists attended the program. The program was jointly organized by National Human Rights Commission Province Office Dhangadi and INSEC. In the meeting situation of human rights and human rights defenders in the province were discussed. Review on the laws and policies of provincial government. In the program Jhankar Rawal, Director of NHRC has presented the guideline of human rights defenders and Khadak Raj Joshi, INSEC province coordinator presented the human rights defender protection model law prepared by INSEC.

Parliamentarians representatives of civil society organizations, human rights defenders and media person agreed to make a collective effort for protection and promotion the human rights defenders who are at risk. Based on the constitutional provision government needs to ensure implementation of policies for the protection of human rights defenders' rights. A effective coordination and support between civil society organizations and government is needed to sensitize and to protect the rights of citizens. Law makers also expressed their commitment to initiate for the formulation of human rights defender protection law in the provincial assembly.

## INSEC's INITIATIVES IN COVID-19

Pandemic of COVID-19 has affected across the country. In the challenging situation, INSEC has engaged its initiation through the documentation of human rights situation, analyzing the impact of COVID on the rights of people across the country. INSEC has been disseminating information regarding preventive measures and the health protocols of COVID-19 through inseconline, social media, research publications and Digital Archive System. Conducted awareness raising programs for the prevention of COVID-19 through interviews, interaction, drama, PSAs from radio program which were broadcast from Radio Nepal, and the local FMs. Advocacy through the various virtual platform to create presser to the government and responsive mechanism to ensure the rights of people regarding the health, food and information etc.

INSEC provides some humanitarian support during the COVID-19 pandemic situation:

- INSEC contributed One Million Four Thousand and Fifty-Four Nepali Rupees to the Corona Virus Infection Prevention, Control and Treatment Fund established by Nepal government. The amount was the contribution from its full-time employees of Seven days' salary.
- INSEC Nepalgunj office provided food relief support to 123 most vulnerable family of Rapti Sonari Rural Municipality.
- Human Rights watch group members of Saradha and Banghad Municipality of Salyan District supported local government in awareness raising of COVID-19, data collection of needy people, and relief distribution activities at the local level.
- INSEC Bagmati Province office provided health equipments to the local government of Makwanpur Hetauda sub metropolitan city, Manahari Rural Municipality, Chitwan Khairhani, Rapti Municipality and Chaungu Narayan Municipality.
- INSEC Sudurpashchim province office provided food materials to the 15 families in vulnerable situation in Krishnapur Municipality Kanchanpur.
- INSEC Gandaki Province office provided health equipment to Fedikhola Municipality.
- INSEC Province One office provided health equipment to Morang's Dhanpalthan Municipality.
- INSEC participated in the networks formed by NHRC to monitor Human rights situation at the district and province level and worked for human rights through committees.

# SUCCESS STORIES

## NEPAL HUMAN RIGHTS YEAR BOOK AND FACT-FINDING REPORT SERVED AS EVIDENCE FOR THE JUDICIAL PROCESS

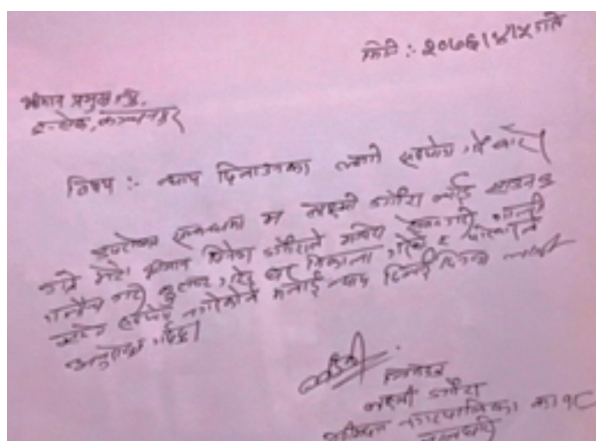
**M**ohammed Aftab Alam, politician of Nepali Congress has been arrested and remanded in a judicial process in 2019 October 13. The allegation was about his alleged connection with an explosion and the subsequent mass murder in Rautahat district on 10 April 2008, just before the first Constitution Assembly Election. INSEC had documented the incident in detail in the Nepal Human Rights Year Book published in 2009 in a detailed fact-finding report. According to the local people information, the deceased had been cremated and the injured were burnt alive at nearby brick kilns. The case was documented in the Nepal Human Rights Year Book in 2009 as a major case of violation of the right to life. The Nepal Police and district court has referred the report of INSEC as a major evidence for



the investigation and verdict. National media highlighted the finding of the Nepal Human Rights year book to disseminate the scenario of the incident. INSEC has been continuously advocating for justice for the victims and their families on such cases.

## LAXMI DAGAURA FINALLY LIVED HAPPILY IN PEACEFUL ENVIRONMENT WITH THE FAMILY

**L**axmi, 21, a victim of domestic violence received legal support from INSEC's District Representatives. She was beaten by her husband and forced to leave home. She had also faced pressure against filling complaint on her case. However, she submitted an application to the District Representative of INSEC for a legal support. Coordination with Women, Children and Senior Citizen Service Directorate, Women and Children Development Centre, she was able to file a complaint against her husband. Later, accused her husband and the family were fined



from the concerned authority for their actions. With the commitment not to repeat such



violence in future, her husband took Laxmi back to home with assurance of respect and support. “I was able to fight for my self-dignity and care

after getting support from INSEC District Representative” the victim Laxmi Dagaura Bhim Datta Municipality-18, Kanchanpur said later on.

## RIGHT TO INFORMATION ENSURED IN THE SUPPORT OF INSEC

**B**ajura District Police arrested 16 persons related to the banned CPN led Netra Bikram Chand (Biplav) on November 8, 2019 from Gaumul Rural Municipality. All the arrested were kept in the custody. The family complained that the police administration did not provide information about their situation and also did not allow meeting with them. Coordination with NHRC, NGO Federation, INSEC had visited the custody and met with the police administration and the detained persons. The family further complained about the corporal punishment from the police in the custody. The families of the detained were able to meet after the initiation made by the civil society groups. After the visit



family members of detained persons provided them warm clothes. Police administration also provides proper information to the family and took them to the court for the legal process.

## BHIM RECEIVED JUSTICE

**B**him Bahadur Rawal, 62, of Krishnapur Municipality, Kanchanpur has four sons. He has a joint family of 17 including 4 daughter-in-laws and grandchildren. He has transferred all his property in the name of his sons. His sons started to live separately and ignoring their parents. He lives alone with his wife. The senior citizen couple is struggling with different challenges after they cut off from all their rights on the property. Bhim Bahadur's wife got paralyzed while trying to fetch water. He urged his sons and daughters-in-law to take care of him and his wife but they did not provide them any support.

Bhim Bahadur shared his problem with Kamala Shrestha, a member of the Human Rights Group. In order to settle the issue, HRG facilitate him and coordinate with the municipality office. Ramita Rana, deputy mayor of the municipality and coordinator of the local judicial committee organized the meeting with all his sons and



daughter in law in the presence of HRG members. Meditate to settle disputes regarding the rights of the couple. Finally the children of the couple realized their mistake and apologize with the couple. In the presence of mediators and elected representatives the children make commitment to care of their parents. Now, the couple has been receiving proper treatment from their children.

## LANDLESS FREED KAMAIYAS SAVED FROM DISPLACEMENT

Ten household freed Kamaiyas who were living temporarily on a public land in Dhangadhi sub-metropolitan city-8 since 2006 were displaced from a decision of the local government to evacuate the place. The families submitted the complaint at INSEC Sudurpashchim province office. INSEC and NHRC conducted onsite monitoring on November 3, 2019 and met with the family. The team finds out that Narayan Baral the ward chairperson initiated the planning of health post without consulting with people using the land since 14 years. The news was published in the INSEC online and other Media.



## GAUNGHAR (COMMUNITY) HEALTH CLINIC IN JHUPRAKHOLA BADI COMMUNITY STARTED PROVIDING SERVICE

Jhupra Khola Badi community is located at 10 KM east from Birendranagar Municipality ward no 11. Around 116 household families stay near the bank of Bheri River. The Community Health Clinic Program had been stopped since last year in this community. People of the community especially senior citizens, pregnant women, and children had to go to main city area for minor health services. Low economic status and marginalized people were deprived from the basic health services. Identifying the issues, HRG planned to advocacy on the issue to ensure the health service of this community people. HRG submitted a delegation paper to Birendranagar Municipality, Municipal Health department and ward office demanding for the implementation of Community Health service at Badi Community on 18th June, 2019.

Addressing the demand, Municipality Public Health Sub-Department commanded Pipira Urban Health Centre to resume Gaunghar (Community) Health Clinic Program. After continue follow up of HRG by pressurizing responsive stake holder, Community Health Clinic program started to conduct twice a month.



Health Clinic's Medical Personal Sobha Adhikari informed that in each program around 40 to 45 patients are benefited. INSEC province coordinator and HRG members requested ward chairperson, Nandalal Sharma for expansion of services from two to four times in a month and to provide sufficient medicines as the government mention for the free medicine services. Finally, Jhupra Khola Badi Community people are benefited from regular health services.

## INSEC LIBRARY

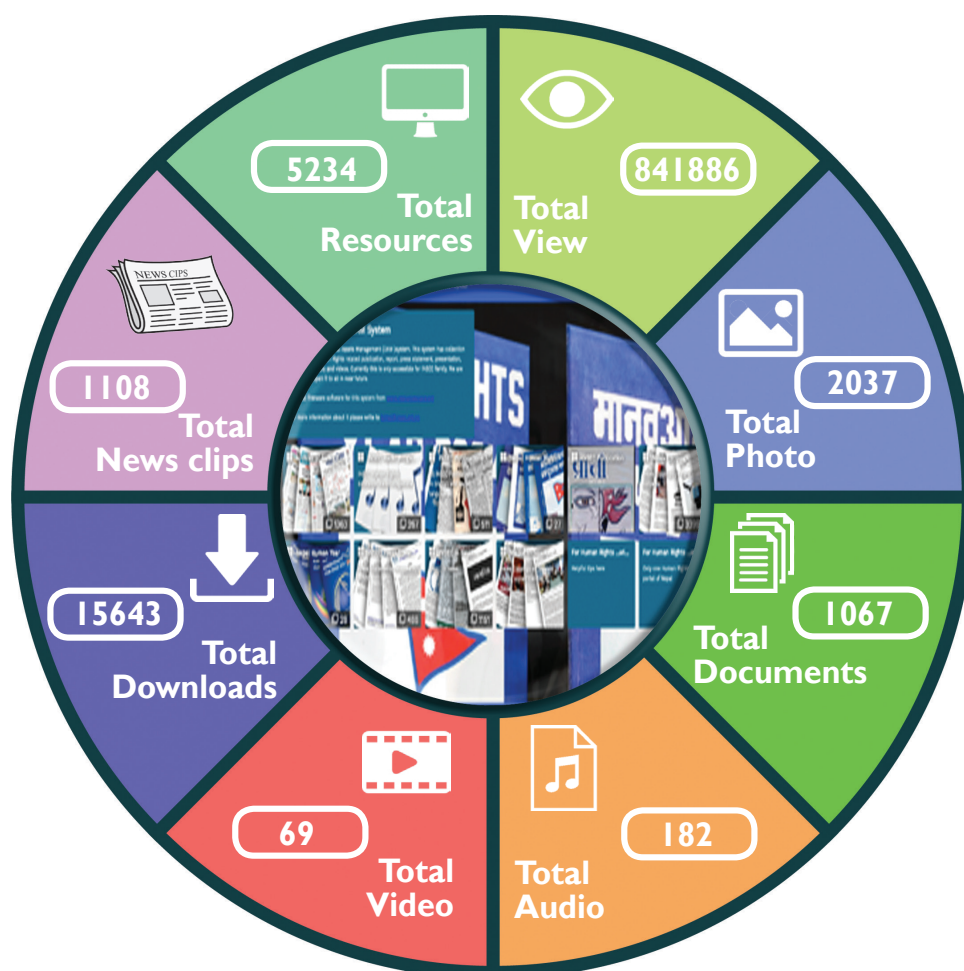

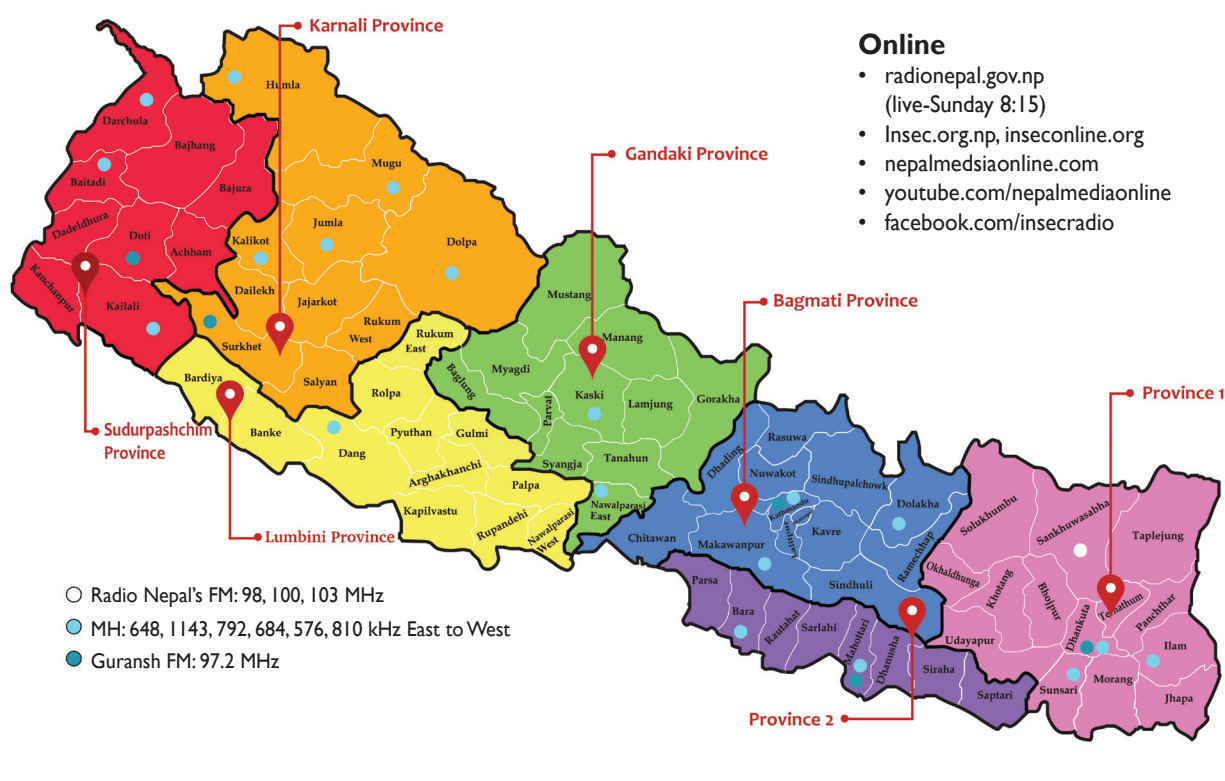
### Data of INSEC DAM System
