INSEC's documentation shows that the cases of rape, attempt to rape, sexual violence, harmful social practices like witchcrafts, dowry practices and Chaupadi are the major contributing factors resulting in the increase of women rights violation in Nepal. The urgency is pointed out to contribute more to make gender friendly policies and mechanisms for the protection of women from the marginalized section of the society.

Informal Sector Service Centre (INSEC) is delighted to present its Annual Report 2021, which highlights the major interventions, achievements, learning and engagements undertaken from 15 July 2020 to 16 July 2021 based on the Strategic Plan 2019-2023. Human Rights Monitoring, Documentation and Advocacy, Human Rights Education and Institutional Development are key programs of INSEC.

INSEC focused on the monitoring and documentation of the cases of human rights violation and abuses, along with evidence-based advocacy to uphold social justice across all 77 districts of the country with the support of district representatives. In coordination with the local networks, INSEC organized awareness campaigns regarding economic, social and cultural rights of the people including rights to education, rights to health, rights to food and housing in 70 local government units of 35 districts. INSEC works to strengthen its institutional capacity through networking, strengthening its own system and implementing the program through the seven province offices and central office.

INSEC played a crucial role in bridging the gap between local stakeholders and the people amid the surge of COVID-19 in order to address the local issues via responsive mechanisms. In coordination with the 440 civil society organizations, INSEC prepared the Universal Periodic Review (UPR) Report. INSEC has published the 29th edition of Nepal Human Rights Year Book which has documented the incidents of human rights violation and abuse across the country. INSEC's documentation shows that the cases of rape, attempt to rape, sexual violence, harmful social practices like witchcrafts, dowry practices and *Chaupadi* are the major contributing factors resulting in the increase of women rights

violation in Nepal. The urgency is pointed out to contribute more to make gender friendly policies and mechanisms for the protection of women from the marginalized section of the society.

INSEC focused on enabling the people, especially women and children from the marginalized communities to assert their rights to education, food, health and housing. They have been capacitated through various activities to make claims regarding various economic, social and cultural rights with the concerned government stakeholders. INSEC put efforts in exerting pressure for the ratification of international human rights treaties, documentation and monitoring about their effective implementation. It has further facilitated the strengthening of the coordinative and collaborative relation between local and provincial government mechanisms, supported the formulation of human rights friendly laws and policies at the local level, contributed in capacity enhancement of local judicial committees, and knowledge enhancement of the youths.

With great appreciation, we express our gratitude to our funding partners, local, province and federal governments authorities, CSOs, Local networks (HRGs and CRAG) who have trusted the objective of INSEC. HUMAN RIGHTS DOCUMENTATION AND ADVOCACY PROGRAM


NSEC has been contributing to Human Rights protection and promotion through Human Rights monitoring, documentation, dissemination and evidence based advocacy since its establishment. Nepal Human Rights Year Book was conceptualized in 1992 after realizing the need for a comprehensive documentation of Human Rights situation in Nepal, publication of the same is continued till this date. INSEC works on the dissemination of information via different sources like INSEC Online, INSEC Human Rights Library, INSEC Digital Archive Management (DAM) System as well as publishes thematic situation reports periodically.

Documented evidences, finding issues, facts and figures of Human Rights reports are the key foundation for advocacy on a Human Rights friendly environment. INSEC continuously collaborates with civil society organizations, local, province and federal level governments, international communities, national and regional level networks and coalition and experts to improve the Human Rights friendly legal and policy framework and its enforcement for reducing Human Rights violations and abuses. Human Rights documentation and advocacy works of INSEC aims to further strengthen the accountability of the state in fulfilling its commitments under the constitution of Nepal, international Human Rights treaties and conventions and Human Rights principles.

According to the data and information collected by the District Representatives of INSEC, this year 5,543 victims of human rights violation and abuse were documented. Out of them, 675 were the victims of violation by the state and 4868 were the victims of abuse. This year, the yearbook discussed the accountability of the commitment of the state towards the citizens.



HUMAN RIGHTS EDUCATION PROGRAM

nder the human rights education program, INSEC conducts human rights awareness and capacity development of local people regarding their Economic Social and Cultural Rights through literacy, awareness campaign, training, network formation and mobilization, interaction, dialogue and discussion with the public and stakeholders. This program contributes to the 70 local government units of 35 districts. The major objective of this program is to ensure the access of legal and social information to marginalized and underprivileged communities. The program aims to enable these groups in claiming their rights including right to housing, health, education and food.

MOBILIZATION OF CAPACITATED HUMAN RIGHTS DEFENDERS FOR PROTECTION AND PROMOTION OF HUMAN RIGHTS IN NEPAL

The project focused its interventions towards mobilization and capacity enhancement of Human Rights Defenders (HRDs). Intervention through this project targets to strengthen the network's capacity and performance of HRDs for social justice and human rights friendly environment.

Objectives

- I. Real time basis HRV cases documentation with increased capacity of INSEC district representatives (DRs).
- 2. HRD protection and promotion ensured through strengthened and accountable intuitional mechanisms.
- 3. Collective Campaign and Advocacy efforts to ensure safety of HRDs.

- 1. Institutionalization and publication of Digital Nepal Human Rights Year Book 2021.
- 2. During the prohibition order HRV survivors specially GBV victims could not get access to police and court to report their cases. Members of the helpdesk Operation Committee helped them to the justice process through in person and telephone. They have provided emergency support such as financial, counselling and shelter.
- 3. Through media and Public Service Announcement (PSA) awareness raising campaigns have been carried out in Lumbini, Karnali and Sudurpaschim province. Necessary information regarding health services and contact point during the emergency were disseminated through radio program.
- 4. INSEC has documented 6267 victims of human rights violation and abuses in 2021. Among the documented victims; 481 were the victims of human rights violation and 5786 were the victims of human rights abuses. The majority of the victims 3445 were related to the violation of women rights.

- 5. 75 District representatives of seven provinces are provided refresher training on HRV system which support to enhance their capacity to use the digitized HRV system to document the human rights violation and abuses cases.
- 6. Province level HRD networks established and functioning in Karnali, Sudurpashchim and Lumbini provinces for the protection and promotion of human rights defenders' rights. They are also part of human rights help desk where they recommend and approve the victim support through the help desk.
- 7. HRDs networks of Lumbini and Sudurpashchim province submitted 20 press notes to district administration office and provincial government to protect the rights of people during COVID-19 pandemic.
- 8. Draft the model Law of HRD Protection and Promotion and submitted to Honorable Krishna Bhakta Pokharel, the Chairperson of Law, Justice and Human Rights Committee along with Sudurpashchim and Lumbini province government.

INCREASING ACCESS OF LOCAL PEOPLE ESPECIALLY DISADVANTAGED GROUPS TO PUBLIC RESOURCES AND GOVERNMENT SERVICES/ ENTITLEMENTS IN REGARDS TO EDUCATION, FOOD AND HEALTH

Local People especially disadvantaged groups to public resources and government services/ entitlements in regards to education, food and health" from Nov 2018 to Nov 2020 in seven local governments of seven districts covering all the provinces of Nepal. The program aimed at making local people aware of their Economic, Social and Cultural (ESC) rights especially on the issues of right to education, food and health. Program contributed in capacitating local people to demand their rights to be fulfilled by the stakeholders and government agencies as ensured by the state's constitutions, policies and provisions. Alongside, the project also intended on pressurizing the local government to amend law and policies based on human right approach while strengthening the capacity of local government officials, elected representatives and other stakeholders to address the issues of women, minorities and indigenous people.

Objectives

- 1. Strengthen local people's capacity to claim their rights especially right to food, health and education towards service delivery procedures in the newly changed governmental structure.
- 2. Capacitate local bodies including female elected bodies (Mayor, Deputy Mayors, ward chairpersons, and ward members) to incorporate ESC Rights while formulation of Policies.
- 3. Pressurize responsible authorities to be accountable in the issues of ESC Rights.

- 1. Spread awareness amongst local beneficiaries regarding their Rights.
- 2. Connected community people and local stakeholders through the Human Rights Watch Group to identify the local issues and their solution through the inclusive participation from planning to implementation process.
- 3. Initiated to facilitate and advocacy for the formulation of human rights friendly plan and policies in the seven local governments.

- 6. Supported the vulnerable and minorities based on their need in the COVID-19 situation and facilitated the coordination with the local government.

ADDRESSING THE PROTECTION ISSUE OF HUMAN RIGHTS DEFENDERS INDUCED BY COVID-19 THEREBY AUGMENTING THE RIGHTS OF EVERYONE (ADHIKAR)

The program entitled "Addressing the protection issue of human rights defenders induced by COVID-19 thereby augmenting the rights of everyone (ADHIKAR)" implemented from January 2021 to December 2021 with the financial support of DCA. Program implemented at four local government units of Lumbini and Sudurpashchim Provinces (Kailari rural municipality and Gauriganga municipality of Kailali district and Baijanath and Duduwa rural municipality of Banke district).

The project intervention focused on protecting and promoting the rights of HRDs and created democratic civic space for Freedom of Expression and Assembly through empowering the HRDs, local institutional mechanisms and creating the enabling environment for HRDs to function safely during the pandemic.

Objectives

- 1. Strengthening HRDs and CSOs Network for collective engagement to Promote and Protect the rights of HRDs, enable social justice movement and democratic Civic Space.
- 2. Collective Campaign and Advocacy efforts to ensure safety of HRDs and rights enjoyed by the citizens.
- 3. Strengthening the institutional mechanism to create an enabling environment for HRDs to function effectively.

- 1. Total 44 members including 16 male and 28 female from the inclusive community engaged in the HRD networks. Strengthen the capacity of HRDs via collective engagement to protect and promote the rights of HRDs. Enhanced the knowledge and skills of more than 93 HRDs in the social justice movement, democratic space through providing the training like Be Safe Training, Safety of the people HRDs work for and on HR related instruments.
- 2. District level HRD networks in Sudurpashchim and Lumbini province mobilized during the Covid-19 pandemic and advocacy for the support.
- 3. Issues of HRDs have been raised through the regular documentation, interaction and discussion, broadcasting PSA and news through social media, radio program, and publication. Coordination with the CSOs drafted the model bill for the protection of Human Rights Defenders.

- Public Interest Litigation (PIL) was registered in the province high court on the issue of non-payment of Covid-19 insurance amount to the public.
- Provide support (financial, psycho social counseling, referral to free legal aid) for 14 survivors of human rights violations coordination with Human Rights.
- Human Rights helpdesk has been established and functioning with the collaboration of INSEC, NHRC, BAR Association, Journalist's association, partner organizations of DCA and CSOs in Lumbini and Sudurpashchim provinces. These help desks provided support to the HRVs victims through providing psychosocial counselling, case reporting and documentation for the legal process. Total 6267 HRVs cases have been documented and 14 HRVs survivors were supported through the HR helpdesk under ADHICAR project.

RIGHTS AND ECONOMIC DEVELOPMENT FOR NEPAL'S EMPOWERED WOMEN (RENEW)

Rights and Economic Development for Nepal's Empowered Women (RENEW) is gender equality integrated program implementing from 2020 to 2023 in Makawanpur and Nuwakot districts. The objective of the program is to enhance social and economic empowerment of women and girls especially Dalit and most vulnerable groups. INSEC has contributed to enhance the knowledge and skills of local women group members on Human rights based approach and advocacy skills. Program supported to empower women in their economic and social growth through training, interaction, cooperation, motivate their confidence, and advocacy for their meaningful participation in the decision making process and leadership roles. Different training and facilitation workshops on Human Rights and Gender Based Violence have been provided to women group members and local government authorities which contributed to enhance the knowledge and skills of these groups.

Objectives

- 1. The Project aims to enhance the social and economic empowerment of women and Girls especially from Dalit and most vulnerable groups by bringing a Human Rights based approach.
- 2. It will support the enhancement of the exercising of Human Rights by women and girls by promoting Human Rights and building stronger institutions.
- 3. Increasing community knowledge and understanding Human Rights issues affecting most vulnerable women and girls.
- 4. Increasing capacity of local partners NGOs serving women and girls to advocate for women's Human Rights.

- Contributed to enhance the knowledge and skills of women, girls of Shivapuri and Manahari Rural Municipality to identify the human rights issues and advocacy for their rights.
- Formed the referral mechanism and support to enhance case management skills and tools.
- Discussed on the women rights issues at the community level through public hearing and interaction with the stakeholders. Local government units, stakeholders and local networks of Makawanpur and Nuwakot take ownership to promote and protect the rights of women.
- Engaged the inclusive participation of men and boys on the issues of women through the men and boys engagement approach to minimize the GBV and Human Rights issue of community.

YOUTH EXCHANGE PROGRAM

ith the funding support from Norec, Youth Exchange Program has been implemented since 2015 by INSEC as the coordination partner and PVCHR as the other implementing partner. Collaboration between INSEC and PVCHR, youth exchange program entitled" Sahakarya (Coordination)" has been implemented through applying their experience and expertise on networking and advocacy. The Program aimed to support partners and participants, through strengthening their capacity and knowledge enhancement. The program also aims to strengthen the capacity of youth volunteers through exchange learning module for their knowledge and skills transformation, learning multi-culture, human rights issues in Nepal and India. Besides these, the program aims to contribute to the human rights movement at the local, national and, regional levels through networking coordination and collaboration.

Objectives

- Strengthen the capacity of youth volunteer on HR situations in terms of understanding, promoting and protecting the rights.
- Strengthening the regional collaboration/network between the partners.
- Increased awareness among youth volunteers on the issues of Human Rights especially focused on education and health issues.
- Strengthened the capacity of youths on evidence based advocacy on the issues of Human Rights violations.

INSEC felicitated with Bhagat Sarwajit Manav Maryadha National Award

Informal Sector Service Centre (INSEC) has been felicitated with Bhagat Sarwajit Manav Maryada National Award-2077 on July 9, 2021. INSEC was honoured with this award in the category of Human Rights for being a voice of Dalits. The Award ceremony was organized by the Ministry of Culture, Tourism, and Civil Aviation of the Government of Nepal. INSEC has been carrying out public awareness activities and movement against caste-based discrimination since its establishment.

Bhagat Sarwajit was a social leader involved in the movement for Dalit awakening during the Rana regime, therefore, the award was initiated after his name in 2072 BS (2015/16). During the Rana rule, Sarwajit Bishwakarma had gone to India to study the Vedas (religious texts of Hindus). After he returned, he started a Dalit movement in Baglung. Every year, the Government of Nepal felicitates 3 people or organizations who are efficiently involved in the movement of Dalit awakening. The honour provides opportunities and recognition of INSEC Dalit movement. It encourages INSEC to continue advocacy on the issues of Dalit and minorities community.

In the initiation of INSEC Laxmi received citizenship

axmi Mudiyari, 22, of Gadhi Rural Municipality-3, Sunsari district urged INSEC to take initiative for justice after her father did not cooperate for her citizenship getting process. She appealed at INSEC Province I Office on March 24, 2021 to bring her father and mother at District Police Office, Morang and District Administration Office and support in the process. After the initiation of INSEC she received her citizenship at the age of 22.

Laxmi was born and grown up in her maternal grandparents' house. Her mother had been separated with her father due to domestic violence and torture before she was born and her mother did not have marriage registration certificate. As her father rejected to make her citizenship with his name. She was in trouble and was deprived from the rights provided by the state including higher education. At the age of 22, victim appealed with INSEC for the support. INSEC team met with both the parties and convinced her father to register marriage certificate with his wife Jagani and gave citizenship to his daughter Laxmi Mudiyari.

Domestic violence survivor able to stapes legal process and access to justice after getting emergence support

Sita Kumari Bhandari (Sarki), 33, of Bheri Ganga Municipality-11, Surkhet, who was the victims of domestic violence and polygamy get legal and financial remedies with the support of INSEC. She has a 10-year-old daughter and a six-year-old son. She had been physically and mentally tortured for not bringing a dowry. Bhandari had been living at home with pain. Her husband left her and started living with second wife since August 29, 2019. He neglected to cover household expenses.

Bhandari came in contact with the Human Rights Helpdesk of INSEC and asked for assistance. Advocate and member of human rights defender Geeta Koirala has supported her to file a case against her husband in Surkhet District Court. INSEC Karnali Province Office has assisted Sita to meet her daily expenses incurred in the legal process.



Tulsipur High Court, Dang issued interim order to Ghorahi Cement Factory to stop air pollution

Chorahi Cement Industry was established in Laxmipur VDC ward number 6 and 8 of Dang District. The industry started producing Sagarmatha cement after four years of establishment. The industry is three kilometers away from Ghorahi, 200 meters away from school area, 200 meters away from health post and consist of crowded residential area around it. Some of the areas around indurstry belongs to the community forests. People around the industry were suffering from air pollution produced by the factory.

The transportation of raw materials to the industry causes destruction of roads, formation of haze of dust. It deteriorates the soil quality. The water sources are polluted and fresh water is not available for the irrigation and drinking purpose. The industry also produces sound pollution and various allergic problems in people.

A writ against Ghorahi Cement Industry was filed in High Court Tulsipur on March 20, 2021 for causing pollution. The writ was filed in the initiation of INSEC including other 21


organizations and local people. The Court asked

to submit environmental study agreements, consent process documents with people and stakeholders. The Court has also passed interim order to control the air pollution created by cement factory.

Submitted the UPR report from the civil society organization in coordination with the CSOs, coalition and networks



UPR report was prepared by three coalitions, the Nepal National Coalition for UPR (NNC-UPR), National Women Coalition and Durban Review Conference Follow-up Committee (DRCFC) Nepal. The coalition comprised 440 civil society organizations. The report was prepared following two national consultations, seven provincial and eight thematic consultations along with 924 participants and concerned stakeholders. Participants included representatives from the National Human Rights Commission (NHRC), government, sexual minorities, Muslims, religious minorities, Dalit and Madhesi communities, indigenous peoples (IPs), journalists, lawyers, freed bounded laborers, child rights activists.

Human Rights Member's effort contributed to benefit farmers from the Prime Minister agricultural modernization program

According to Maya Chaudhary, Member of Human Rights Group of Kusum Rapti Sonari Rural Municipality, there was no agricultural aid program. Lack of leadership from farmers, lack of acquaintance with people's representatives, real farmers were deprived from the government program benefit. Chaudhary was associated with the human rights group on January 9, 2019. She associated with all the programs and activities conducted by the committee. She got chance to participate in various platform and enhance her capacity. She started to raise community's issue with the stakeholders. Currently, Maya leads Shree Mahalaxmi Women's Cooperative Ltd with the aim of re-establishing trust of people towards the cooperative.

Now, Maya leads the programs worth 19 lakhs 80 thousands which include pocket program, Prime Minister agricultural modernization program, food crops promotion program, and maize pocket program. She became a respectable social leader in the community. She has increased the number of shareholders of the cooperative from 150 to 500. She made arrangements of fertilizers for the farmers even during the lockdown and has made a transaction of around 12 lakhs from the cooperative. Ward Chairperson of Rapti Sonari Rural Municipality-I has praised the works and efforts of Maya towards the community. Animal department head Jaya Karki appreciated the works of Maya in the agricultural sector. Now, Maya is happy and satisfied with her initiatives and contribution to uplift the backward farmers and marginalized community females situation.

2020, the chairperson of primary health center management committee Pashupati Parajuli assured to demand for the operation of X-ray service with the health department of the Rural Municipality. The problem was raised in different discussion programs, later the recommendations were submitted to different concerned authorities. The continuous monitoring and pressures from human rights group, contributed to establish the X-Ray Service at Health Post.

Community people are benefitted from the low cost and quality services in their own community. The initiation of HRG and INSEC was appreciated by Vice-Chairperson of the Rural Municipality Deepa Gautam, health department head Bishnu Paudel and senior HA of primary health center Ram Das Tharu. They assured to provide continuous service to the people.

HRGs and CRAG becomes change maker in Community Schools of Dhanpalthan

here were no school management committees in all schools of Dhanpalthan Rural Municipality. Most of the schools lacked proper facilities of water, toilet, snacks and sanitary pads for girls. Even though the teachers of schools demanded for these facilities with the local administration, but their demand were ignored.

The Human Rights Group and Child Rights Awareness Group members conducted different interactions and dialogues between students, teachers and local government bodies. Regularly discussed to solve the problems.

During the interaction, participants shared the problems faced by the school family. They demand to form school management committee and parents teachers committee to improve the quality environment of school. In the presence of education department head Sita Bhattarai, Rural Municipality ward chairperson Hari Lal Singh and concerned stakeholders, HRG and CRAG organized dialouge program to address raising issues of Dhanpalthan school. The representatives committed to fulfill the issues raised in terms of priorities.

Education department head Sita Bhattarai informed that the school management committee and parents teachers committee have been formed in all 36 community schools of the Rural Municipality. Similarly, ward education committees were formed in all seven wards of the Rural Municipality. Regularly 7 to 20 number of students will be provided sanitary pads every month with six per student. Further, day snacks have been being provided to the students of class 1 to 5 in all 36 community schools.
